Min upset over slow pace in solid waste disposal

STAFF REPORTER ■ BHOPAL

Urban Development and Housing Minister Bhupendra Singh expressed displeasure over the slow pace in solid waste management for disposal of garbage in cities.

He instructed to prepare a concrete policy within a week for the processing of waste in other bodies apart from 109 urban bodies included in the seven clusters. Setting up of small solid waste processing plants may be considered in urban bodies as per requirement. Shri Singh said that it must be ensured that there is no garbage heaps anywhere in the cities under any circum-

Singh said that action should be taken soon in respect of clusters, for which tenders have been called for solid waste management. Work has started only in Sagar and Katni out of the seven clusters. He said that necessary action should be taken within 7 days for starting plant in Gwalior. Singh said

should be taken against the officer concerned. He said that the decision regarding Neemuch and Khandwa cluster should also be taken within a week. Rewa plant should be started within one and a half

Singh sought information about the 'Gandagi Bharat Chhodo Madhya Pradesh' campaign. He said that ranking of the cities must be done properly in the campaign. Daily reports regarding the campaign in cities must be

Singh said that a city-wise action plan should be chalked out and reviewed constantly to complete all the works of 'Amrut Yojana' by March-2022. Payment for the works must also be made in time.

He said that tenders should be cancelled in places where the action are not being taken in time for transportation within the city. While reviewing the Pradhan Mantri Awas Yojana,

that if there is negligence at the municipal level, then action incomplete houses should be completed soon.

The Minister said that the process for making master plans of cities for which master plans have not yet been made should paced up. Commissioner Town and Country Planning informed that the master plan of Indore will be ready in the next four months. Shri Singh gave instructions to complete the survey work of property tax of cities. Regarding the auction of unused land of urban bodies, he told to consider giving the right of auction to the urban

Seven deaths, 412 fresh Covid-19 patients in U'khand

The forward march of the novel Coronavirus (Covid-19) contagion in Uttarakhand is continuing without any hindrance. The state health department reported seven deaths and 412 new patients of the disease on Monday that increased the tally of the patients of the disease to 15529. The CM's economic advisor Alok Bhatt is among those who tested positive for Covid. So far 207 patients of Covid-19 have died in the state. On the day, 412 patients of the disease were discharged from different hospitals after their recovery from the disease. In the state a total of 10912 patients have recovered so far from the disease and the recovery percentage in Uttarakhand is at 70.27 percent. The doubling rate of the disease in the state is at 26.03 days. The infection rate

in the state is now at 5.23 percent. What is cause of concern for the health expert is the fact that a staggering 12495 samples are remaining untested in different labs of the state. The doubling rate of the disease in Uttarakhand now stands at 26.03

critical positive patients were undergoing treatment. Out of them, 50 belonged to Chandigarh, 69 to Punjab, 23 to Haryana, 12 to Himachal Pradesh and remaining from other states. There are 53 patients admitted in Dhanwantri College and 152 patients in Sood Dharmshala. In the past 24 hours, 616 COVID samples were tested by UT Health Department, out of which 445 were of antigen testing. Out of antigen samples, 89 were found positive. The average growth rate of new infections is recorded at 5.5 percent in Chandigarh. In August alone, 1987 cases of COVID-19 have been reported in the city.

Between March 19 and June 30, the union territory had recorded a total of 440 positive cases. However, with easing of ed in the body as an immune

SERO SURVEY TO BE CON-DUCTED IN CHD

With the COVID-19 cases increasing at a rapid pace, the Chandigarh Administrator is gearing up to conduct a serology survey in the city. A serological survey is an epidemiological tool that helps in detecting unreported or past cases of COVID-19 and in understanding the prevalence of the disease in communities.

In the sero-survey, blood samples are randomly collected from various high-risk population groups — based on the categories identified by the Indian Council of Medical Research (ICMR), to look for antibodies against COVID-19. The antibodies are generat-


