Newly posted Divisional Commissioner BM Sharma said that the government's people's welfare schemes will be his priority.

He assumed the office of the new Divisional Commissioner of Gwalior Division on Monday.

While talking to media persons he said that feedback from the public will be taken to improve the services. While answering queries about the laxity of the officials he said that carelessness and lethargy will not be tolerated at any cost.

The new Divisional Commissioner reached the Divisional office situated at Moti Mahal around ten in the morning to take charge. Talking to the media after assuming office he said that Gwalior is not new to him as he had previously served here in three capacities: as DEO, ADM and Municipal Commissioner.

He further said that as Divisional Commissioner he has charge of five districts and this has increased his responsibilities. He empha-

sized on the need to expedite social schemes that have direct impact on the poor. He said that he will try to be the voice of the poor and less fortunate. He also said that his stress will be on direct interaction with the public so that government schemes, especially schemes for the poor can be implemented in the best way possible.

He further said that a counter will be opened in the Divisional office to collect feedback from the public, so that schemes can be implemented in a constructive manner. Arrangement will also be made to resolve matters related to revenue and appeals. He further said that he needs to study the current system before commencing work.

Before taking over as the Gwalior Divisional Commissioner, Sharma was the Divisional Commissioner in Shadol. He was appointed as the Gwalior Commissioner after the retirement of SN Rupla. A huge gathering of public, officials and staff had gathered at the Moti Mahal to welcome the new Divisional Commissioner.
