Hariharan-Arjun retire on day 1 of China Masters



Unnati Hooda fell at the first hurdle in women's singles, while men's doubles pair Hariharan Amsakarunan and M R Arjun retired at the first-game interval of their opening-round match at the China Masters Super 750 badminton tournament here on Tuesday. Hooda, ranked world No. 25, went down 10-21, 18-21 to South Korea's world No. 12 Kim Ga Eun in the opening round.

Earlier, Hariharan and Arjun were trailing 8-11 in the opening game against China's Chen Bo Yang and Liu Yi when they decided to concede the match. The reason for their retirement was not immediately clear, although it appeared to be related to fitness. Hooda looked out of sorts in the opening game as Kim raced to a 4-0 lead and quickly stretched it to 11-3 before closing out the game. (PTI)

Man City bolsters attacking options by signing winger Allan



Manchester City signed Brazilian winger Allan and reportedly reached an agreement to purchase Senegal forward Iliman Ndiaye on Monday in an effort to strengthen its attacking options late in the transfer window.

The 22-year-old Allan moved from Palmeiras for 34 million pounds (\$46 million) and takes the place in the City squad vacated by Savio, who joined Tottenham last week. He is likely to have the same role as his compatriot - as a backup winger. Allan has never played for Brazil or for any of his country's age-group teams, so he arrives as a somewhat low-profile signing.

"This is a surreal moment for me," Allan said in a City statement. "Manchester City, with everything they have won over the past 15 years, are one of the most attractive clubs in the world for players. To be able to sit here today and say I have joined them is the proudest moment of my life." (AP)

Carlos Alcaraz returns to US Open with a victory, Sabalenka also wins her first match

Carlos Alcaraz returned to the U.S. Open and looked healthy enough for a run at a repeat.

Alcaraz beat Roman Safiullin 6-4, 6-4, 6-4 on Monday, showing no problems with the right wrist injury that had sidelined the 23-year-old Spaniard since April.

Following fellow two-time U.S. Open champion Aryna Sabalenka onto Arthur Ashe Stadium, the No. 2-seeded Alcaraz appeared more comfortable as the match went on and delivered the all-around game that has made him a fan favorite in New York. He held his hand to his ear to encourage louder cheers and pumped his fist after a pretty volley winner in the final game of the match.

"I'm just really happy that I was able to compete again," Alcaraz said. "I think the level of tennis is going to be better for sure. I'm just really happy with the level that I played my first match."

If the seven-time Grand Slam champion stays healthy, he may quickly become a huge favorite with top-ranked Jannik Sinner sidelined by a knee injury and No. 4 Novak Djokovic losing in the U.S. Open's first round for the first time on Sunday.

With the tournament thrown into shock by that result - Djokovic had been 19-0 in the first round at Flushing Meadows, where he won four of his men's-record 24 Grand Slam titles - Sabalenka brought back some normalcy.

Sabalenka beat Camila Osorio 6-4, 6-4 to begin her bid to be the first player to win three straight U.S. Open championships



since Serena Williams from 2012-14.

She has been to the last three U.S. Open finals, rebounding from a loss to

Lionel Messi has graced a soccer field with Argentina for the last time. Arguably the greatest player of all time, Messi announced his retirement from the international game on Monday to bring an end to 21 years of service for his country.

Balogun is headed on transfer to Premier League club Everton

United States striker Folarin Balogun is set to head to Premier League team Everton on a transfer from Monaco, British media reported on Monday.

The transfer fee offered by Everton is reported to be in the range of 40 million pounds on a four-year deal, the British Press Association said. It said personal terms had yet to be worked out before the deal could be completed prior to Tuesday's transfer deadline.

The 25-year-old Balogun, who had two years remaining on a contract at Monaco, gained attention this summer scoring three goals

for the United States as it reached the knockout stage of the World Cup. He was the top scorer for the US team. He also made headlines after drawing a red card and a one-game suspension in a 2-0 victory over Bosnia and Herzegovina in a round-of-32 match.

The one-game suspension was deferred by FIFA after US President Donald Trump intervened, allowing Balogun to play in the round of 16. Balogun eventually played in the 4-1 loss to Belgium that ended the US team's home World Cup run. The intervention prompted a formal complaint to FIFA ethics investigators.

Stan Wawrinka's Grand Slam career ends as the 2016 US Open champion falls to Matteo Berrettini

Stan Wawrinka's Grand Slam career ended Monday when the 2016 US Open champion lost 7-6 (4), 7-6 (3), 6-0 to Matteo Berrettini.

Wawrinka won the last of his three major titles in Flushing Meadows when he beat Novak Djokovic in the final 10 years ago. At 41, he was given a wild card into the event in what he has said will be his final season before retiring.

"I'm going to miss it for sure. I'm going to miss it big time. I love the game," Wawrinka said before he was honored on the court by US Tennis Association officials. The match appeared similar to meeting between the same players at Wimbledon, when Berrettini won a four-setter, with each going to a tiebreaker.

But after Wawrinka had his serve broken to start the third set — despite winning a key point when video review was used — Berrettini quickly pulled away. Wawrinka made his 18th US Open appearance. He initially

thought he wouldn't get a goodbye to the tournament when the USTA gave its final men's singles wild card to American Patrick Kypson, who is

ranked No. 115. Wawrinka had already come to New York, so decided to return home last Monday to Switzerland. (AP)



Wimbledon champion Linda Noskova is back in Grand Slam mode at the US Open

Linda Noskova's life changed earlier this summer in ways she could not possibly imagine. The 21-year-old from the Czech Republic won Wimbledon, the youngest champion there in a decade and a half, for her first Grand Slam title. She met Czech president Petr Pavel and was celebrated by thousands in her hometown of Vsetin.

"A lot of congratulations from people that weren't really expected," she said. Back at a major for first time at US Open, Noskova understands the gravity of what she has accomplished but insists it has not changed how she approaches tennis, with her eyes on more prizes ahead. "It has always been very important to focus on each match like nothing ever happened before: no success or no failure," Noskova said. "Whatever happened happened, and this is a brand-new tournament. I just have to start all over."

It's not totally starting over. She will always have that Wimbledon run on her resume, and she has improved from 12th to a career-best sixth in the WTA world rankings.

Still, Noskova called not getting ahead of herself the most important thing, which she believes is easy. After falling behind 5-2 in the first set of her opening match Monday against 78th-ranked American opponent Katie Volynets, Noskova rallied to win it 7-5, 6-1.

"I really want to stay the same - not really change many things around me," Noskova said. "Whenever there is something new or something I'm not used to, I just kind of always want to stick with the things that I know how to do, and whatever is new, I just kind of get used to it."

Knowing it's about "What have you done for me lately?" Noskova acknowledges the media attention will not last forever. Going all the way at the All-England Club did give her confidence that she can hang with the best women's players on the planet, which helps at a US Open that looks wide open.
